#### DIVING OFF NAVFAC GRAND TURK in 1967 (The Fish Weighed More Than I Did) Submitted by JEFF DODGE

For me, fun and free time at NAVFAC Grand Turk was pretty scarce. It way my first duty station after OCS, so I had lots to learn as OWO as well as Special Services to deal with. In early 1966, a few months before I arrived, the NAVFAC flunked its ORI and Special Services was among the areas "needing attention".

None-the-less, the combination of the Atlantic Ocean next to the Facility and my interest in diving motivated me to ask if there were any divers around the base. Surprisingly, only five or six guys out of 110 or so stationed there ever went diving that year. My normal diving buddies included: Lt(jg) Bud Hilton, Research Officer; STG2 Mike Upshaw, Supervisor; and STG3 Doug Nash, Reader.

Through my Special Services connection, I obtained catalogs from dive equipment manufacturers offering discount prices to the military. Bud and I ordered gear, including spear guns (these were PC back in the 1960's) for our selves and for Special Services. SCUBA was out as the CO, LCDR Mike Wehling, was afraid we'd kill ourselves; we were restricted to snorkeling. The CO might have been right. Late in my tour I had to be rescued from a Sunfish sailboat as it headed toward Portugal with the daughter of the Governor of the Caicos Islands aboard - but I'm drifting away from my story.

Our group went diving as often as our schedules allowed; maybe 3 or 4 times a month. We usually dove 150-200 yards offshore behind the BOQ in about 25' to 35' of water. The diving there was excellent, weather permitting, and the coral and sea life were beautiful. But after a few months, we needed to kick up the excitement factor a notch.

We did this by cutting up fish we had speared and throwing them overboard to attract sharks. We'd dive in when they were spotted and try to spear them, but truth be told, we never got a shot off as they were quite timid. I'm sure the CO would not have approved.

Months after we began diving together, Bud ordered a "12gauge power head" through a catalog. The power head attached to a pole or rod and used a blank 12-gauge shotgun shell to kill the subject (fish) on impact from the concussion. We didn't have blank shotgun shells, so we took regular shells from the Armory and removed the lead shot, and sealed the end with melted wax. We were now ready for big game and more excitement.

It was our first or second day diving with the power head when we came across a huge jew fish in about 25' of water. We first only saw his head as he was backed into a cave in the coral. The cave was actually a tunnel about 4' long with the other entrance on the back of a coral outgrowth. The four of us met at the surface to discuss our strategy, which was for three of us to spear the fish simultaneously from both ends of the tunnel and the 4<sup>th</sup> guy was to use the power head. We went back down. Three of us fired our spears on the signal. You never saw such a thrashing as the giant fish twisted and turned, eventually exiting the tunnel with twisted steel spears dangling from his body. The poser head was employed and the resulting concussion ended the struggle. (Remember this was all OK back then)

Getting the fish up and onto the boat was not easy, taking all four of us. We hurried back to the BOQ to show the "guys" and take a few photos. <u>Editors note: I have seen the photo and validate it being one very big fish!</u> Next we went over to Supply to weigh it. It weighed in at 235 pounds. We went across to the Mess Hall to see if the cooks could do something with it, like prepare it for dinner. One of the local cooks' helpers told us it was too big and wouldn't be good eating. "Full of worms", he said. Saddened, we decided to take it to town and give it away. The next day we heard that guy we gave it to had cut it up and sold it piece-by-piece around town.

My wife and I have gone back to Grand Turk four times in the last ten years to dive and enjoy the absence of tourists. We love the Salt Raker Inn and the diving is really great. Spear fishing is not allowed and almost all diving is on the "wall" off Cockburn Town.

Anyway, I noticed on my first or second trip that there was a skeleton of a huge jew fish head hanging on the dive shop wall at Blue Water Divers. I asked Mitch, the owner, about it and he said he inherited it from the previous dive operation in the late 1970'sor early 1980's. It's since been stolen, but I often wonder if it was our old friend from 1967?

## NAVFAC PACIFIC BEACH REBORN AS A RESORT

The following is extracted from a article written by Daily World Writer, Paula Horton, that appeared in the Aberdeen Daily World newspaper in September 2001.

After a \$2.5 million facelift Naval Facility Pacific Beach, WA is now the Pacific Beach Resort & Conference Center. Active duty personnel, reserved and retired military, as well as DoD employees and their families can now relax in luxury at the 39-room resort. The 30 cabins along the bluff - once housing for Naval Facility personnel - are also available for rentals. "This is a world-class set-up," Capt Daniel L. Squires, USN, Commanding Officer of Naval Station Everett said at the ribbon-cutting. The resort features a new grand entrance that leads to the registration desk and gift shop, and the redesigned Windjammer restaurant and bar, with a view of the ocean. The rooms were renovated from the ground up and now feature new paint, carpets and furniture. Guests will also find TV's, VCR's, phones, coffeemakers and microwaves in each room or suite. A new heating and air conditioning system was also installed with individual controls in each room. Part of the redesign of the resort included adding a third floor to house four Jacuzzi suites. Ocean waves can be seen for the 300 square foot suites or from an outdoor viewing deck adjacent to the suites.

Before it was a Naval Facility, Pacific Beach had an interesting history. (Editor's note) The Pacific Beach Hotel was originally built in 1906 and became known as one of the Northwest's most romantic "honeymoon hotels." After Pearl Harbor, the U.S Navy took over many resorts and campgrounds along the Pacific Coast. The hotel at Pacific Beach was converted into offices for a regional headquarters. Recruits trained in anti-aircraft procedures at Pacific Beach by shooting at targets pulled by Navy planes flying out of Westport. After the war, the Navy offered to sell the facility back to the community for \$1.00, but there were no takers. The base sat unused until 1950 when the U.S. Air Force converted it to a radar station for five years. In 1958, the Navy took control of the facility for a second time and used it as a Pacific Coast base until 1987. There was great anxiety in the community over the loss of jobs. The 52-acre compound was then developed into a recreational resort for military personnel to help increase morale, quality of life and retention.

### Evolution of SOSUS/IUSS Signal Processing (Part 1 of 2)

Fourteen shore stations were installed on the initial phases of the CAESAR Program, implementing the fixed sonar R&D designs of Project JEZEBEL and the Hartwell Report in the Atlantic Ocean regions. Beginning with first 40-element hydrophone array terminated at Eleuthera in the Bahamas, April 1952. These first systems were officially designated AN/FQQ-1 (V) Sonar Sets. The (V) suffix signifies that the equipment configuration for the FQQ-1 was variable – dependent upon the requirements of the underwater plant and the desired analysis and display characteristics.

The AN/FQQ-1 (V) Sonar Set consisted of diesel engine alternators supplying basic 60 Hertz power, two motor-generator sets furnishing 400 Hertz power, 66cabinets of electronic, electromechanical and power units, interconnecting wiring, and of course the multi-pair cable connected to an array of 40 hydrophones on the ocean bottom. In the shore equipment, there were 441 separate electronic sub-assemblies and over 2000 vacuum tubes. Two cabinets of 40 vacuum tube amplifiers boosted the very low level incoming signals [acoustic data converted to a minute electrical voltage by the hydrophone] and spectrum equalized them for correlation into 40 directionallyoriented geographic beams radiating out from the array location. This "beam forming" was performed by the Electrical Delay Line (EDL) group of 24 cabinets, containing 960 Inductive-Capacitive Delay Networks and 192 Delay Line Amplifiers. The incoming hydrophone signals were delayed by a pre-determined amount of time in order to form directional "beams". Each directional "beam" was then sent to a group of Spectrum Analyzers that extracted acoustic frequency components from the Delay Line outputs through the use of an electromechanical, bifacial recorder-multiplier. One spectrum analyzer and recordermultiplier were required for each beam, and the acoustic data was displayed through the process of a sweeping, electrically-charged stylus that physically marked a continuously moving electrosensitive chart paper [one display chart for each of the 40 directional beams]. The second phase of CAESAR saw the first major change in shore processing. The first six Pacific-based systems [beginning with San Nicolas Island in March 1957] received this equipment, designated AN/FQQ-2 (V). The primary benefit of the FQQ-2 was replacement of the 24 equipment cabinets of Electrical Delay Lines with two Magnetic Delay Line (MDL) cabinets [one active and one standby or spare]. The MDL's main features were a large rotating drum containing 40 continuous recording tracks, 40 magnetic recording heads, and 1600 signal pickup heads. Thus the directional beam forming was again performed through a "delay and sum" technique; this time produced by a physical recording process rather than an electrical interaction.

Phase III introduced the second generation of CAESAR undersea cable systems, the SB coaxial system which was based on a multiplexed commercial telephone suppressed carrier using a single wire circuit for all data instead of a separate pair of wires for each hydrophone channel. The AN/FQQ-9 Sonar Set prototype was installed at Eleuthera in May 1962. Production models installed at Adak, Alaska, in August 1962 and Argentia,

NFLD, in September 1963 included another upgrade to shore processing. The original spectrum analysis equipment was replaced by a new form of processing called "Digital Spectrum Analysis" or DSA. DSA took advantage of the then-state-of-theart advances in electronics to move from an electromechanical signal multiplication (analysis) process to a more accurate and stable beam sampling delay time compression process. The electro-mechanical Sonar Data Recorder was maintained as the as the gram display device; however, an updated model was installed along with DSA. At this same time, 1962-62, the entire system installed to date was a back fit with DSA and the station designators were changed to AN/FQQ-1A (V) and AN/FQQ-2A (V). The improved Sonar Signal Processing Groups received separate designators: AN/FQA-4 (V) for the FQQ-1A systems, and AN/FQA-5 (V) for the FQQ-2A systems. With DSA back fit, the SOSUS System entered CAESAR Phase IV.

A further enhancement to signal processing occurred with the Vernier Back fit Program in 1966-67. This back fit added more complete and flexible auxiliary signal processing and display features and added flexible tape recording and data transmission capabilities through installation of the AN/FQA-7 (V) Data Analysis Central.

The third generation cable system had been under development at Bell Labs during the late 1960's and in September 1972, the first SD-C coaxial system was terminated at Centerville Beach, CA. This system, SD-C1, was officially designated AN/FQQ-11 (V). The shore equipment was composed of an: AN/FQA-15 High Voltage Power Supply for the sea cable, an AN/FQA-12 (V) Receiver Group to demultiplex the hydrophone signals, the thenstandard FQA-5 (V) DSA signal processor, and the FQA-7 (V) Data Analysis Center.

When SD-C2 was operational at Brawdy, Wales in July 1973, it included: an improved AN/FQA-14 Power Supply [where improvements were made to the site power generation and distribution equipment, none to the cable power plant], a standard AN/FQA-12 (V) Receiver Group, and more significantly, a major update to signal processing. This signal processing suite was called the G642170 Sonar Signal Processing Group. It was the first true digital processing system, but since it did not include the computer-aided detection system then under development by Bell Labs, it was called the Manual Array Processor (MAP). This processing suite included the Computer-Oriented Partial Sum beamformer (COPS I) and the Real-Time Signal Processor (RTSP I). Both systems used digital computer technology to form directional beams and extract acoustic signals for display, but this point, the technology was "hard-wired" so to speak and readily adaptable (programmable) for varying configurations. Brawdy also had an AN/FQQ-12 SOFAR Monitoring Set (CORMSO) which was intended to monitor and record seismic or transient-type acoustic events.

Between 1976 and 1978. COPS I and RTSP I systems replace the MDL beamformers and DSA processing systems at the forward area stations: Argentia, Keflavik, Centerville Beach, and Adak. Basically, for this point, SOSUS shore system technology was changing at a rate that outpaced the AN/FQQ-FQA military numbering process. As result, subsequent installations and upgrades do not clearly adhere to the Army-Navy nomenclature scheme. [End Part 1 of 2] To be continued next issue.
