CAPT Jim Donovan, USN (Ret)



A native of North Quincy, Massachusetts. Captain Donovan enlisted in the Navy in July 1973. He advanced through the enlisted ranks as an Ocean Systems Technician (Analyst) filling assignments within the Integrated Undersea Surveillance System (IUSS) including: Fleet Sonar School, Key West, Florida; NAVFACs Bermuda, Keflavik, Iceland, and Barbers Point, Hawaii; and Readiness Training Facility, Centerville Beach, California. He achieved the rank of Chief

Petty Officer in September 1981.

Captain Donovan was commissioned as a Limited Duty Officer (desig 6120) in March 1983 and reported to Naval Facility Keflavik, Iceland. Follow-on tours include staff, Commander, Oceanographic System, Atlantic in Virginia and NAVFAC Brawdy, Wales.

In 1994 Captain Donovan transferred to the General Unrestricted Line (desig 1100) and was assigned to Naval Ocean Processing Facility, Dam Neck, Virginia as Operations Department Head. In October 1995 he reported for his third tour at Keflavik, Iceland where he served as Executive Officer and U.S. Naval Facility Keflavik's last Commanding Officer. In 1997 Captain Donovan returned to Norfolk and was assigned to the staff of Commander-in-Chief, U.S. Atlantic Fleet. In August 1999 he became the 10th Commanding Officer of Naval Ocean Processing Facility Dam Neck, Virginia.

In September of 2001, Captain Donovan transferred to the Information Professional (desig 1600) community and was assigned as Chief Staff Officer, Naval Computer and Telecommunications Area Master Station, Atlantic (NCTAMS LANT) in Norfolk, Virginia. Following a one-year tour at Naval Network Warfare Command (NETWARCOM), Little Creek, Virginia, Captain Donovan assumed Command of Naval Computer and Telecommunications Area Master Station, Pacific (NCTAMS PAC) at Wahiawa, Hawaii on 15 July 2005. He retired from the Navy effective 1 December 2007 following a 34-year Navy career.

Captain Donovan is a graduate of the Naval War College, the University of the State of New York, and Troy State University where he earned a Master of Science in Management.

Personal decorations include the Legion of Merit, Meritorious Service Medal (4 awards), Navy Commendation Medal (5 awards), Navy Achievement Medal and Good Conduct Medal.

Captain Donovan is married to Captain Kathy Donovan who is assigned to the staff of Commander, Carrier Strike Group Ten (USS HARRY S TRUMAN). They reside in Virginia Beach, Virginia. *If* you recall, theirs was the unique experience of serving back-toback tours as Commanding Officer, NOPF Dam Neck -- a first in the annals of Naval history. Captain Donovan is also the proud father/grandfather of four children and three grandchildren.

"Life after SOSUS" Grand Turk Island

The Turks and Caicos Islands – adrift on the fringes of the Caribbean sit at the bottom of the Bahamas chain, nature's afterthought 575 miles southeast of Miami. But Grand Turk's ship has come in. This tiny island once received perhaps 10,000 visitors a year. It's now welcoming an estimated 300,000. In February, 2006, Holland America Line's **MS Noordam** became the first ocean liner to dock at the Island's Grand Turk Cruise Center.

There's no facility like it in the Caribbean. A 1,033 ft dock leads to a 13-acre day-use resort of groomed beaches; showers & lockers; a shore excursion pier; taxi and tour vehicle queues; a swimming pool (NavFac's??); 45,000 sq. ft. of retail space; and a large Jimmy Buffet's Margaritaville Restaurant with a swim-up bar. All it took was a vision – and about \$50 million from Carnival Corporation, the parent company of 12 cruise ships that range from Carnival Cruise Lines' bargain "Fun Ships" to Cunard's **Queen Mary 2.**

JO (CDO) DAY IN THE BARREL

Editor's Note: A recently published book, titled <u>Scorpion</u> <u>Down: Sunk by the Soviets, Buried by the Pentagon</u> that alludes to a Navy cover up as to what actually happened has stirred a controversy among many System people, lead by Bruce Rule, who were involved first-hand with the SCORPION disaster. We refer to this book as the second Aesop's Fables. There is no intent to belabor that dialog here but Joe has shared a bit of how it was for a Junior Officer (JO) serving as duty watch officer at the COSL Evaluation Center on Sunday, 2 June, 1968.

While I had not read the book in question, I have some very clear memories of the events following the loss of USS SCORPION. The weekend following Memorial Day I happened to be on watch as COSL CDO, when every 4-star within commuting distance of Norfolk descended on NH-95 (CINCLANTFLT OPCON BLDG) and wanted a briefing. I believe it was on Sunday, and I was running my usual slack watch – newspapers on the plotting table, Krispy Kreme donut boxes at strategic locations. I took a break and headed to the gedunk near the SubLant front door when I noticed more gold braid and stars than I ever wanted to see. I was a skittish Lt(jg) at the time and still had an unhealthy respect for O-3's. I beat it back to the security of the display room and had just put my feet up on the desk and started to relax when the sound-powered bat phone rang. It was the ASWFORLANT watch officer giving me a heads-up that the gold-braided entourage was inbound for COSL with an ETA of about two minutes.

I had a fairly junior watch section: with the exception of my Evaluation Watch Officer -- I think it was Ensign Marv Day -- my next senior person was a seaman who happened to be a DP whom Marv and I had been training as an ST. Anticipating a quiet weekend, I probably had given my section LPO the watch off. Go Figure! But that DP was really sharp. If I had had the time, I would have seen my brief naval career flash before my eyes, but I was otherwise occupied. We scooped papers and donuts out of sight and while I raced back to the Analysis spaces for the appropriate plots and grams, I sent the seaman to stand by at the front door and I clearly remember the contrast between the array of O-5 sideboys at SubLant and the seaman on the front door at COSL. I told Marv to get on the phone and call everybody he could think of. As it turned out, Captain Al May (COSL) had gone to Nantucket for an inspection and Capt Bolan (CSO) was unavailable. Mary finally reached the Ops Boss, CDR Jack Felter, who headed our way at warp speed. A word of explanation here; I knew where all the plots and supporting information were secured in the 20 (Analysis) shop because, as an unattached JO, I had plenty of spare time. I had met the plane bringing the data from Argentia at the Norfolk airport. So, I naturally stayed close to what was

going on, crawled around on the floor getting my hands dirty working with the grams, helping where I could and generally getting in the way when I couldn't help, which was probably most of the time. But I looked and listened and it paid off when CINCLANTFLT, COMASWFORLANT, COMSUBLANT, et al came knocking that Sunday morning.

The Admirals were duly briefed and went on their way and I headed for the gedunk for a well-deserved coke. As I headed out the front door of COSL I met Jack Felter coming up the stairs 3 at a time and asking, shouting, "Where are they, where are they!!??" When I told him they'd come and gone, his frantic query changed to, "What did you tell them!!??" You see JOs were not to be trusted to talk to Admirals. Apparently, I told them the right things in the proper way, for I was allowed to remain a watch officer.

Now, finally to my point: the chart that I briefed to the CINC had two probability areas. One was ours, based on the timedifference analysis from ARG and possibly some tenuous data from a couple of downrange stations. There was so much data to review, and what we were looking for was so subtle, I don't think we would have been successful without the AFTAC input to give us a starting point. It was real needle-in-the-haystack stuff. The other area was derived from AFTAC and I believe Woods Hole was some how involved in analyzing some data. The discrepancy between the two areas (which were pretty close but did not overlap by much, if at all, to my recollection) was caused by the fact that one of us used a spherical model and one used an elliptical model in the calculations. I won't pretend to remember which, but it gave us a starting point for the search and eventually the wreckage was located.

I also recall a Soviet submarine operating somewhere south of the Azores which sparked the initial confrontation speculation, but it was not within hundreds of miles of the track that the SCORPION would have taken from the Med to Norfolk. So that's my story. One cannot disprove a negative, and there will always be a market for conspiracy theories; they are so very profitable!

I can't believe how much time has passed since those heady days when the System was supreme. One certainly cannot miss the Cold War with its threats of instant nuclear annihilation, but there are times when I long for those days of relative stability. You knew who the enemy was.

"Scorpion Down: Sunk by the Soviets, Buried by the Pentagon: The Untold Story of the USS Scorpion" - A Rebuttal

Ed Offley's book, <u>Scorpion Down, Sunk by the Soviets,</u> <u>Buried by the Pentagon: The Untold Story of the USS</u> <u>Scorpion</u>, has serious credibility problems in areas that relate to acoustic data. We focus the following rebuttal on Offley's allegations that are based on acoustic data, the analysis of which is our forte.

Offley makes the following accusations, which are central to his conspiracy theory, on the indicated pages:

- Naval intelligence officials conducted a massive operation in May 1968 to confiscate and destroy all (acoustic) documentation of a hostile encounter (between SCORPION and the Soviet ECHO II Class nuclear submarine) (pp. 287).
- (2) That Naval Intelligence agents had impounded the SOund SUrveillance System (SOSUS) data within hours of SCORPION's sinking (pp. 290).
- (3) The Navy not only seized the SOSUS evidence to prevent it from becoming public but also suppressed it to manipulate the SCORPION Court of Inquiry deliberations from ever finding out what actually had happened to the submarine (pp. 290).

It is the agreed position of 15 individuals with a collective total of 400 years of experience at SOSUS sites and/or activities that analytically supported SOSUS that there was no conspiracy to confiscate, suppress, or destroy any SOSUS data that could have been related to the loss of SCORPION. In accordance with standing operating procedures all data were sent to the SOSUS Evaluation Center in Norfolk, VA where they were exhaustively analyzed. The results of that analytical review were disseminated within Navy channels and beyond as appropriate. Most of the 15 individuals whose names are listed above participated in that collection and analysis effort. No data were sent to the Office of Naval Intelligence (ONI) nor did "Men in Black" from ONI visit SOSUS stations and make "all the usual threats" (pp. 288) to station personnel about disclosure. Bottom line: Ed Offley's conspiracy claims are utterly false.

None of the fifteen of us was interviewed by Ed Offley nor, to our knowledge, were any other former (or current) ONI or SOSUS Evaluation Center personnel interviewed by Offley.

Offley also contends there was a tape recording from a SOSUS station (in the western Atlantic) that recorded an "underwater dogfight" (pp. 283) between SCORPION and an ECHO II that ended when the ECHO II fired a torpedo and sank SCORPION. In accepting the existence of such a tape, one has to explain the following:

- How did a SOSUS station at least 1500 nautical miles (nm) from the position of the SCORPION wreckage make such a detection when a Canary Island sensor, in the East Central Atlantic at a range of about 400 nm, did not, even though the Canary Island sensor detected strong SCORPION collapse (implosive) events?
- (2) As a corollary to (1) above, how could a SOSUS station in the western Atlantic have detected two submarines and a torpedo when the far more detectable "massive initial pulse of sound" from the collapse of SCORPION was detected by only one SOSUS station (Argentia, NFLD) and then only as a weak signal?
- (3) Why, during the purported hostile encounter, was the ECHO II, as described by Richard Falck (pp. 285), operating in the "split-plant mode" when operation in that mode made the ECHO II (a) noisier than if using both propeller shafts to achieve the same speed, (b) reduced its maximum speed capability by 8 knots, and (c) decreased its maneuverability by increasing its effective turning radius, while operating against a submarine that was both much faster and more maneuverable? A comparison could be made to a bus attempting to catch and outmaneuver a sports car.
- (4) Why were these detections not reported in real time to the SOSUS Evaluation Center in Norfolk, VA, as required by standard data reporting procedures? We reject the suggestion (pp. 285) that the dogfight/torpedo tape could have been recorded from an air-dropped sonobuoy because (a) there is no record of such air-collected data, (b) multiple buoys (a pattern) are always dropped and Offley's source (Falck) made no mention of multiple detections of the same event on the tape, and (c) such an origin would require yet another "massive conspiracy" of silence, this time by the USN aircommunity.
- (5) Why did the tape first appear 14 years after it was supposedly recorded and then at an ASW Training Center, and what has happened to it since?

"Scorpion Down"- A Rebuttal, continued

These anomalies and inconsistencies indicate the purported SOSUS hostile encounter detection tape was created at the ASW Training Center, as was often done, by copying three unassociated detection events (a U.S. nuclear submarine, an ECHO-II, and a torpedo) onto a single tape for training purposes. This tape was then misrepresented to impressionable personnel at the school as detection of a hostile encounter between SCORPION and the ECHO II.

Bottom line: the purported SOSUS encounter tape did not record a single, real event.

In an article that appeared in the 17 June 2007 edition of the <u>Honolulu Star Bulletin</u>, Dr. John Craven, Chief Scientist for Navy Deep Submergence Programs in 1968, described the SCORPION-associated acoustic events detected by the Canary Island acoustic sensor as a "massive initial pulse of sound, then silence for 91 seconds," then "a train wreck cascade of smaller sound impulses."

The condition of the SCORPION wreckage on the bottom in 11,100 feet of water indicates the pressure hull collapsed at great depth. As already pointed out by several reviewers, this could not have happened if the pressure hull already had been penetrated by an explosion from a torpedo or any other explosive event because the entire submarine would then have been flooded (pressure equalized) before the hull sank to collapse depth. The condition of wreckage therefore indicates the "massive" initial acoustic event was hull collapse at great depth and the "train wreck cascade of smaller sound impulses" was produced by the collapse of smaller, more-pressure resistant structures such as spherical tanks.

There were no explosive events (only collapse/implosive events); hence, theories that SCORPION was sunk by a pressure-hull penetrating explosion by (1) one of its own torpedoes, by (2) a Soviet torpedo, or by (3) any other explosive events are not viable.

Conclusion: SCORPION most likely sank to crush depth with the pressure hull still intact because of an onboard problem the crew could not correct.
